# C. Special Obligation Refunding Bonds, Series 2019 (Emergency Reading)

Todd Goffoy, special financial advisor with Piper Jaffray, stated the competitive bidding process began today. Four responses were received with interest rates ranging from 2.29%-2.62%.

City Manager Jim Feuerborn provided a review of the staff report in the Council packet. The Series 2019 Hubach Hill Transportation Development District bonds were issued in an amount of \$7,695,000. Currently, the debt service associated with the Transportation Development District (TDD) are paid from the Capital Improvement Sales Tax Fund. This refunding will level the principal payments throughout the remainder of the bonding period. After the sale of the bonds this morning, an amended version of Bill 3498 has been distributed reflecting the refunding amount of \$5,870,000 resulting in a savings of 28%. The savings in the interest rate is \$1,736,616.40 with a net present value of \$1,757,312.71. This refunding will reduce the amount of payments from the Capital Improvement Sales Tax Fund and the savings will be used to fund future projects. The emergency request is that November 1, market rates tend to increase. After the refunding, Moody's rates the City's credit rating at Aa2. He referenced Section 3.13 of the Charter and Section 110.290 of the City Code which exempts the reading of bond ordinances in their entirety. He answered general questions from Council.
