A. <u>Call In Utility Payments</u>

Finance Director Elisa Williams will be making a presentation to the City Council on a proposed new program for taking utility payments over the telephone.

B. Failure to Appear - Municipal Court

State legislation regarding the court's ability to suspend driving privileges on minor traffic violations has significantly impacted the amount of warrants can be generated. Mayor Turnbow will be providing data and discussing his efforts to generate new legislation more favorable to the courts.

C. SB-526 Video (Cable) Franchise Fee Legislation

Despite receiving communication from the Raymore City Council and many other municipalities to request that he not, Senator Emery proceeded with filing SB-526. This bill is a significant attack on a municipalities ability to collect revenue to offset costs associated with maintaining the utility right of way. Mayor Turnbow and City Manager Jim Feuerborn will be outlining several of the points associated with this legislation.

D. <u>City Initiated TIF - Foxridge and 58 Highway Area</u>

City Manager Jim Feuerborn will be discussing with the City Council the concept of initiating a TIF for the purpose of future redevelopment on three of the four corners of this intersection.
