- Staff participated in a Zoom meeting with Belton and Grandview city staff to continue collaboration on submitting a Planning Sustainable Places grant application.

- AT&T submitted plans to add communication equipment to the existing cellular tower located south of the South Metropolitan Fire Protection District station on 58 Highway.
- Joe Duffey, representing Park Side LLC, filed an application for rezoning of 160 acres located south of 163rd Street, west of North Madison Street, from A (Agricultural) to PUD (Planned Unit Development) to allow for a 376-unit single-family subdivision called Park Side.
