## **6. Committee Updates**

### a. Public Art Committee

Commissioner Berry noted the committee met Thursday and reviewed the detailed proposal for Hawk Ridge Park's sculpture project and approved the design. Berry spoke about the Little Free Libraries installed by two HOAs and mentioned the possible donation to Ray-Pec art teachers. Berry also mentioned the possibility of temporary or permanent art at T.B. Hanna Station and updated the commission on the Holiday Sing Along on Dec. 7. The sing along would be in person or virtual. Berry talked about the purchase of a new tree for the annual Raymore Christmas Tree Trail.

### 7. Staff Reports

a. Melissa Harmer gave a budget update and asked commissioners to be ready to make final budget decisions at the September work session.

### 8. Consent Agenda

Commissioner Berry moved to approve the July meeting minutes. Commissioner Simpson seconded. The Commission voted 6-0 to approve.

- d. Commissioner Berry voted to approve the final design concept for the Hawk Ridge Park sculpture project. Commissioner Simpson seconded the motion. The Commission voted 6-0 to approve.

#### **11. Commissioner Comments**

Commissioner Simpson thanked the Public Art Committee for the impressive selection of the sculpture for Hawk Ridge Park. Commissioner Berry thanked staff for hard work in coordinating the Little Free Library dedications and wished his wife a happy 30th anniversary. Commissioner Young said he is excited to see the sculpture come to fruition and noted the location was a nice high traffic area. Commissioner Gribble said he agreed with the previous comments. Commissioner Setser congratulated Berry on his persistence with the library project. Commissioner Jones said it was a challenging year and the commission opened up their imaginations to utilize themselves to bring creative ideas to the community and mentioned that the commission is moving forward to fill the empty Ward 2 seat. Commissioner Simpson asked if it was possible to move her at-large appointment to the Ward 2 seat to make it easier to appoint a new commissioner. Jones stated that it could be looked into, but he did have a plan in place and an applicant in mind to fill the seat.
