Commissioner Simpson said there was an impressive amount of work going into the choosing of the art piece for T.B. Hanna Station. Simpson mentioned the idea of community art with scarecrows modeled after an idea she saw from Sleepy Hollow, New York and Carrollton, Missouri, for next year.

Young congratulated the Ray-Pec music department on their outdoor socially distanced performance and said it was important to try to continue to have those experiences during the continuing pandemic.

Commissioner Jones thanked staff for keeping projects going with the Arts Commission during the challenges of the current year and said he was looking forward to what the Commission can do in the future.
