

THE RAYMORE CITY COUNCIL MET IN REGULAR SESSION MONDAY, JANUARY 11, 2021 AT CENTERVIEW, 227 MUNICIPAL CIRCLE, RAYMORE, MISSOURI. MAYOR TURNBOW PHYSICALLY PRESENT WITH THE FOLLOWING MEMBERS PARTICIPATING VIA ZOOM: COUNCILMEMBERS ABDELGAWAD, BARBER, BURKE, CIRCO, HOLMAN, JACOBSON, AND TOWNSEND. PHYSICALLY PRESENT WERE CITY MANAGER JIM FEUERBORN, CITY ATTORNEY JONATHAN ZERR, CITY CLERK ERICA HILL, AND STAFF MEMBERS.

1. Call to Order. Mayor Turnbow called the meeting to order at 7:00 p.m.

Mayor Turnbow announced the procedures for public interaction during the meeting due to COVID-19 procedures currently in place.

Mayor Turnbow observed a moment of silence in honor of Officer Sicknick who died in the line of duty at the US Capitol.

Dan McMurty with USDA Wildlife Services requested to use pyrotechnics to deter birds from a tower located at 310 S. Lincoln.

City Manager Jim Feuerborn reported that staff would proceed as directed by Council, but would not forward a recommendation of approval for the following reasons: there are other effective methods to deter the birds without waiving code, the City would receive numerous calls when the pyrotechnics were discharged, and if code was waived for this instance it would set precedent for other uses in the future. Hearing no comments from Council, Mayor Turnbow declared the request would not move forward for consideration.

6. Staff Reports.

Development Services Director Jim Cadoret reviewed the building activity for 2020. He announced a Good Neighbor meeting on January 21, 2021 for a proposed expansion to Alexander Creek subdivision.

Emergency Management Director Ryan Murdock updated the Council on the City and County COVID case numbers. He stated the City has leveled off on the number of cases. He reviewed the CARES Act fund information and noted the second stimulus package did not include funding local municipalities. He also reported that Missouri has administered around 150,000 doses of the vaccine to front line workers of the 500,000 available to the State of Missouri. Chief of Police Zimmerman stated that she and a few other members of the Police Department received their first dose of the vaccine. He answered questions from Council.

City Manager Jim Feuerborn noted there will be no work session next week due to Martin Luther King, Jr. Day.

B. Calling for the April 6, 2021 Online Use Tax Election

BILL 3595: "AN ORDINANCE AUTHORIZING AND DIRECTING SUBMISSION TO THE VOTERS OF THE CITY OF RAYMORE, MISSOURI AT THE ELECTION OF APRIL 6, 2021, THE PROPOSAL TO AUTHORIZE THE IMPOSITION OF A USE TAX FOR GENERAL REVENUE PURPOSES AT A RATE EQUAL TO THE CURRENT SALES TAX RATE OF 2.50% IN THE CITY OF RAYMORE, MISSOURI."

City Clerk Erica Hill conducted the second reading of Bill 3595 by title only.

City Manager Jim Feuerborn noted that the staffing report recently completed confirms the need for additional staffing that this sales tax would fund if approved by the voters. The proposed use tax would fund the following positions: Police Department - 4 officers and a detective, Public Works - 5 maintenance worker I positions, Parks and Recreation - 3 maintenance worker I positions and a facility and event coordinator.

DISCUSSION: Councilmember Holman asked if we have added any full time employees over the last 6 years. Mr. Feuerborn stated no new full time employees have been added since 3 police officer positions were added in 2011. 7. New Business. First Readings.

A. <u>Tax Increment Financing Plans and Redevelopment Projects - Progress</u> Overview (public hearing)

Mayor Turnbow opened the public hearing at 7:31 p.m. and asked for a staff report.

Economic Development Director David Gress provided a review of the staff report included in the Council packet. In accordance with Section 99.865 of the Missouri Revised Statute, an annual presentation on the progress of the various Tax Increment Financing (TIF) Plans

throughout the City to determine if the plans and redevelopment projects associated with such plans are making satisfactory progress under the proposed time schedules outlined within the approved plans has been prepared. Staff provided a summary of the TIF Plans and Redevelopment Projects within the City: Foxwood Village Shops TIF Plan, Highway 58 West Extended Redevelopment TIF Plan (Galleria), and Highway 58 and Dean Avenue TIF Plan (Raymore Marketplace). He answered questions from the Council.

Mayor Turnbow opened the floor for public comment. The meeting was paused for 2 minutes to allow comments via email, and hearing none, closed the public hearing at 7:43 p.m.

B. Estates of the Good Ranch Preliminary Plat Extension

RESOLUTION 21-02: "A RESOLUTION OF THE RAYMORE CITY COUNCIL APPROVING THE EXTENSION OF THE PRELIMINARY PLAT FOR THE ESTATES AND ESTATE VILLAS OF THE GOOD RANCH SUBDIVISION."

City Clerk Erica Hill conducted the reading of Resolution 21-02 by title only.

Development Services Director Jim Cadoret provided a review of the staff report included in the Council packet. Randal Leimer, representing Great Plains Developments LLC, is requesting a one-year extension to the expiration date of the preliminary plat for The Estates and Estate Villas of the Good Ranch subdivision. The property owner is actively searching for a developer/builder to purchase the property. Staff recently met with a regional builder that is pursuing purchase of the entire property. The approved Master Development Agreement for the property ensures that any development complies with the current development standards and requirements of the City, including stream preservation and water quality treatment. Staff recommends approval of the one-year extension.



BACKGROUND / JUSTIFICATION
Judge Nigro has indicated his desire to continue to serve as Municipal Judge for the City of Raymore.
Judge Nigro met with the City Council at their January 4, 2021 work session and answered questions about the Court and discussed how Missouri Legislative and Supreme Court actions were continuing to impact the court.
Judge Nigro currently makes \$16,500 annually for his service to the City.
The City Manager indicated that the Bill re-appointing Judge Nigro would be brought before the Council for consideration with an increase in the yearly salary reflecting a 2.5% increase in 2019 and a 2.5% increase in 2020 to an new annual amount of \$17,125.

BILL 3597 ORDINANCE

"AN ORDINANCE RE-APPOINTING ROSS NIGRO JR. AS MUNICIPAL JUDGE FOR THE CITY OF RAYMORE."

WHEREAS, on the 4th of November, 1997, the people of Raymore, Missouri, did adopt a Charter form of government which provided among other provisions for the appointment and qualifications and duties of Municipal Judge; and

WHEREAS, Section 7.2 of the Charter provides for the appointment qualifications, term, duties and provisions for compensation of the Municipal Judge; and

WHEREAS, Ross Nigro, Jr. possesses the qualifications prescribed in Section 7.2 of the Charter of the City of Raymore, Missouri; and

WHEREAS, the Mayor deems it to be in the City's best interest to re-appoint Ross Nigro, Jr. to serve a third term as Municipal Judge.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF RAYMORE, MISSOURI, AS FOLLOWS:

- <u>Section 1.</u> <u>Duties and Powers</u>. The Municipal Judge shall perform said duties and powers as presently outlined for the Municipal Judge in the Charter of the City of Raymore, ordinances and the Missouri State Statutes.
- <u>Section 2.</u> Re-<u>Appointment</u>. The City Council of Raymore, Missouri, by a majority of three-fourths (3/4) of all of its members, consents to the Mayor's re-appointment of Ross Nigro, Jr. as Municipal Judge for the City of Raymore, Missouri, for a term beginning February 1, 2021, and continuing thereafter for a term of two (2) years.
- <u>Section 3.</u> <u>Compensation</u>. The compensation of the Municipal Judge shall be \$17,125 per year during the term. Compensation of the Municipal Judge is not dependent in any way upon the number of cases tried, the number of guilty verdicts reached or the amount of fines imposed or collected. No change in compensation of the Municipal Judge will become effective during the term of office. The Municipal Judge is an employee of the City whose compensation shall be payable on the same payroll schedule as all other City employees.
- <u>Section 4.</u> <u>Effective Date</u>. The effective date of approval of this Ordinance shall be coincidental with the Mayor's signature and attestation by the City Clerk.
- <u>Section 5.</u> <u>Severability</u>. If any section, subsection, sentence, clause, phrase, or portion of this Ordinance is for any reason held invalid or unconstitutional by any court of competent jurisdiction, such portion shall be deemed a separate, distinct,

and independent provision, and such holding shall not affect the validity of the remaining portions thereof.

BACKGROUND / JUSTIFICATION

Senate Bill 1181, enacted by the General Assembly in 2008, established the Show Me Green Sales Tax Holiday in Section 144.526, RSMo, which exempts the State sales tax on the sale of certain Energy Star certified appliances annually when purchased on April 19-25. Municipalities may also participate in the holiday to exempt City sales tax from the sale of these items.
To participate in the 2021 Show Me Green Sales Tax Holiday, the City must notify the Missouri Department of Revenue that it will participate in the holiday and provide a copy of the ordinance to that effect no later than March 5, 2021.

BILL 3598 ORDINANCE

"AN ORDINANCE OF THE CITY OF RAYMORE, MISSOURI, COMMITTING THE CITY OF RAYMORE TO PARTICIPATE IN THE SHOW ME GREEN SALES TAX HOLIDAY IN 2021."

Mr. Judd Claussen of Phelps Engineering, gave an overview of the Heartland Dental office site plan to be built on Lot 3 of Raymore Market Center in front of Price Chopper.

City Planner Katie Jardieu gave an overview of the staff report, highlighting that there will be ample parking with 32 parking spaces and that the Engineering Division of Public Works has reviewed the application and determined it complies with City code requirements. One of the trees along Foxwood Drive will be removed, but will ultimately be replaced adjacent to the current location. The light poles currently on site will also remain and no additional lighting will be added, apart from building lighting. Four sided architecture is proposed as well as a five foot sidewalk to connect the site to the sidewalk along Foxwood Drive. No signs are approved with this site plan. An additional condition of approval

was also added, that the mechanical equipment will be screened from view prior to the certificate of occupancy being issued. The applicant has agreed to this condition.

Commissioner Faulkner stated that there was a discrepancy in one of the conditions of approval regarding the height of the electrical equipment screening. The report should read if it is over eight square feet then it should be screened. Ms. Jardieu stated this could be fixed and the eight square feet was correct, as opposed to the twenty-five feet stated.
