### A. <u>Rezoning - Ridgeview Estates</u> (public hearing)

BILL 3650: "AN ORDINANCE OF THE CITY OF RAYMORE, MISSOURI, AMENDING THE ZONING MAP FROM "C-2" GENERAL COMMERCIAL DISTRICT TO "PUD" PLANNED UNIT DEVELOPMENT DISTRICT, AN EIGHT-ACRE TRACT OF LAND LOCATED SOUTH OF LUCY WEBB ROAD, WEST OF DEAN AVENUE, IN RAYMORE, CASS COUNTY, MISSOURI."

City Clerk Erica Hill conducted the first reading of Bill 3650 by title only.

Mayor Turnbow opened the public hearing at 7:47 p.m. and called for a staff report.

Development Services Director Jim Cadoret provided a review of the staff report included in the Council packet. Jason Maddox, representing MACO Development Company LLC and property owner Good-Otis LLC, is requesting to reclassify the zoning of eight acres located south of Lucy Webb Road, west of Dean Avenue, from C-2 "General Commercial District" to PUD "Planned Unit Development District." The rezoning will allow for a proposed 60-unit age-restricted and income-restricted residential development to be known as Ridgeview Estates. This public hearing was properly advertised in *The Journal* and he asked for the mailed notices to adjoining property owners, notice of publication, Unified Development Code, application, Growth Management Plan, preliminary plan, citizen communications received by staff, and staff report to be entered into the record. At its August 17 meeting, the Planning and Zoning Commission voted 8-0 to recommend approval of the rezoning. Any changes to the preliminary plan would require approval from the Planning and Zoning Commission and the Council. He answered questions from Council.

Councilmember Berendzen asked about the possibility of development to the east of the property and if development would be conducted under the PUD. Mr. Cadoret explained that the PUD only applies to the 8 acre tract for this plan, stating that the surrounding land remains commercially zoned and would be required to adhere to those zoning requirements

Dan Sanders, MACO Development Company, 111 N. Main Street, Clarkton, MO, presented a detailed overview of the project. He answered questions from Council.

Mayor Turnbow opened the public hearing for public comment. Hearing none, he closed the public hearing at 8:06 p.m.

Councilmember Townsend asked about the future of the commercial tract to the east of this property. Mr. Cadoret stated that the commercial tract of land would be subject to the requirements of the zoning classification for that tract of land.

Mr. Feuerborn noted that the MHDC request of support will be before Council at the October 4 work session, followed by the official request for support at a future Council meeting.

Councilmember Burke asked about the enforcement of the age restrictions. City Attorney Jonathan Zerr stated it is up to the property owner to enforce the age restrictions.

Mr. Maddox noted that all residents have to be 55 and older per the MOU and land use restrictions.

Mayor Turnbow noted concerns of the location of this project prohibiting the extension of the outer road. Mr. Cadoret explained that the PUD zoning includes the preliminary plat. Staff has had extensive discussions regarding this topic and all involved came to the conclusion that better access to commercial projects along that corridor would be from Dean Avenue, noting that the topography of this area contributes to this decision.

City Clerk Erica Hill conducted the first reading of Bill 3651 by title only.

Development Services Director Jim Cadoret provided a review of the staff report included in the Council packet. At its December 14, 2020 meeting, City Council entered into a Memorandum of Understanding (MOU) with Joe Duffey, representing

Park Side LLC, regarding the proposed Park Side Subdivision. Park Side LLC is no longer affiliated with the Park Side Subdivision and the MOU should be terminated. Bill 3651 authorizes the mutual termination of the MOU. Park Side LLC is in agreement with the termination of the MOU. A new MOU with the new ownership group, containing the same terms and conditions as the existing MOU, is submitted concurrent with this termination.

City Attorney Jonathan Zerr noted the MOU is a recorded document. In order to remove it, we need to terminate the existing and adopt a new MOU with the new owner.

Park Side LLC is no longer affiliated with the Park Side Subdivision and the reimbursement agreement should be terminated. Bill 3653 authorizes the mutual termination of the Design Reimbursement Agreement. Park Side LLC is in agreement with the termination of the agreement. A new reimbursement agreement with the new ownership group, containing the same terms and conditions as the existing reimbursement agreement, is submitted concurrent with this termination. Work had been started with the engineering firm, however, no reimbursements have been made.
