#### **SPECIFICATIONS**

- 1. Replace bid items with the enclosed bid tab.
- 2. Section 01 200 00 Measurement and Payments:

Add Paragraph 3.02.H.3 - Long Service Reconnections

Payment for service reconnections shall include the cost of connecting the old service line to the new main by way of a brass service saddle, tap, service pipe (Type K copper). New service line (Type K copper) shall be ran from the new water main east under Ward Road and at a minimum to the east right-of-way where the connection to the old service line shall be made. This reconnection shall be made after potable water becomes available from the new main.


