Councilmember Berendzen asked if fencing is planned between the property and the Morningview community. Mr. Cadoret stated that it has been discussed with the applicant, but isn't specifically defined in the Memorandum of Understanding (MOU).

Matt Schlicht made himself available for questions. He also confirmed that there will be a fence between the property and the Morningview community. He answered questions from Council.

In September 2022, announcements were made and the Hawk's Nest project was awarded the full \$250,000. Projects were then authorized to go through the open bid process. In December, Staff released an RFP inviting qualified vendors to submit proposals for the all-inclusive playground. Five proposals were received and on January 25, staff presented the Park Board with the three lowest, best proposals for Board review. On February 8, the Park Board held a special meeting to recommend a contract to PlayPower LT Farmington, Inc. in the amount of \$950,000. PlayPower provided a proposal that met all requirements and includes a unique and fun experience utilizing a nature theme in the playground's design. An additional donation in the amount of \$200,000 towards the project was included with the proposal. The Park Board unanimously approved a recommendation to award the contract to PlayPower LT Farmington, Inc. He answered questions from Council.

Councilmember Abdelgawad recognized the work of staff for the fundraising efforts for this project. She also asked about the completion dates. Mr. Musteen stated that the equipment will be ordered as soon as the contract is approved and a hopeful opening of late summer.

Staff has applied for this additional funding in the maximum amount for our project of \$50,260. Announcement of the additional funding is expected in June. Staff is requesting a budget amendment in the amount to fully fund the project and proceed with construction. If awarded the additional funding from LWCF, we do not expect to use the full amended amount.

Councilmember Berendzen asked if there is a camera system for this park. Mr. Musteen stated that there is a camera system at this location and more can be added if necessary.
