THE RAYMORE **ARTS COMMISSION** MET IN REGULAR SESSION TUESDAY, **Feb. 14, 2023**, AT RAYMORE CITY HALL, 100 MUNICIPAL CIRCLE. COMMISSIONERS PRESENT WERE: LOREN JONES, COLE YOUNG, PAT SETSER and JESSICA BERRY. COMMISSIONER BOB BERRY joined via Zoom. COMMISSIONERS RANDEE KRUMWIEDE and WESLEY ANDERSON were absent.

 - a. **2023 Sculpture on the Move Art Selection**

The Public Art Committee will present a list of its top 20 choices (out of more than 100) for the commission's next temporary public art installation at the south end of the Eagle Glen Trail and is seeking approval of the list at this time for the program's "draft day" pm Feb. 28, 2023. 19 other cities are participating in Sculpture on the Move this year and each organization's name will be pulled from a hat at random to decide the order in which the organizations get to pick their sculpture. In the history of the program, no organization has had to go outside of their top four choices since there are so many to select from.
