- House Bill 909 is anticipated to be perfected by the Missouri House on Monday, March 20, and voted on and approved by Thursday, March 23. Once approved by the Missouri House of Representatives, HB 909 will move to the Missouri Senate. House Bill 909, introduced by Rep. Mike Haffner (R-Pleasant Hill), would amend state statute to extend the buffer between a landfill and an adjoining municipality to one mile from its current one-half mile. • Raymore voters will see a proposed 3% city tax rate on the sale of recreational marijuana on the ballot on April 4, 2023. If approved by voters, the tax will NOT apply to medical marijuana sales, only to recreational marijuana sales. Tax dollars would go toward the City's General Fund, which pays for the core administrative and operational expenses of the City. Some of those expenses include personnel, all expenses of the Raymore Police Department, 911 dispatching expenses, Animal Control and court operations, pothole patching, street lights and the electricity for them, snow removal/salt/brine, membership in the program that allows residents to safely dispose of household hazardous waste year-round at mobile collection events and permanent facilities, the annual community paper shredding event and landfill opposition expenses (legal and public relations).

- A variance application was filed by Travis Self requesting a variance to the Unified Development Code Section 440.030(C)2, which allow for a 6' privacy fence to be located at the property line on the west side of the property located at 1535 Horseshoe Dr. in the Stonegate subdivision. The Raymore Board of Zoning Adjustment will consider this request at their April 12, 2023 meeting.
- A variance application was filed by Juan Molina requesting a variance to the Unified Development Code Section 440.030(C)2, which would allow for a 6' tall privacy fence to be located within the required front-yard setback area for the property located at 100 N. Woodson in the Rolling Hills subdivision. The Raymore Board of Zoning Adjustment will consider this request at their April 12, 2023 meeting.
- A variance application was filed by Charles Burnett representing Claremont
  Properties requesting a variance to the Unified Development Code Section 405.030
  "Bulk and Dimensional Standards" for the "R-3B" Apartment Community Residential
  District. The request would reduce the 30' rear yard setback to 15.92' for an
  attached garage structure included within a proposed senior-living facility. The
  property is currently undeveloped, located north of Springing Up Child Development
  Center and east of Johnston Pkwy. The Raymore Board of Zoning Adjustment will
  consider this request at their April 12, 2023 meeting.
- The materials for the March 21 Planning and Zoning Commission were posted online.
  The Commission will review proposed PUD Rezoning and Preliminary Development
  Plan for an approximately <u>22-acre mixed use development</u> located west of Dean
  Avenue, north of Johnston Drive, within the Timber Trails development.
