Councilmember Abdelgawad asked how the landfill issue expenses are being funded. Mr. Feuerborn stated the expenses are coming from the available fund balance.

Councilmember Holman reiterated the commitment to stop the landfill. He stated that each council member represents each citizen of Raymore, not just the ward that elects them.
