Artist payment and allocation of funds for 2024 Sculpture on the Move temporary public art The Raymore Arts Commission budgets \$3,000 total for the temporary art installation in FY2024 to cover the two-year lease (\$2,000 for the artist's full lease payment, of which \$1,000 is paid upon installation and \$1,000 is paid at the end of the lease upon removal), as well as \$1,000 moved into a restricted fund to be used for any maintenance needs during the display period.
