A \$20 filing fee is required at the time the candidate declares candidacy. One seat in each of the four (4) wards will be open to serve a two-year term. #### Parks & Recreation

- Staff finalized the Park Board Work Session Packet for Jan. 10. Discussion at that meeting will include the future of the Raymore Cemetery.


#### **Public Works**

 Crews worked continuously Wednesday evening and Thursday clearing snow from the City's streets. As part of this round of winter weather, staff also continued to test the City's snow plow GPS tracking system.

This new system tracks the progress of every City snow plow as it treats roadways during a winter storm. This allows the city to track what streets have been treated and will give residents a clear picture of how much work goes into clearing more than 350 miles worth of roads in Raymore.

As the City finishes testing the system, residents will soon be able to see in real-time the City's snow plow progress.

Public Works Director Mike Krass said he expects to have the system live to the public by the next snowstorm in Raymore.

 Building Maintenance Technician Daryl Quade and Engineering Administrative Assistant Margie Sullivan coordinated the purchase of floor mats for various buildings. This will result in an annual cost savings of approximately \$3,000 as opposed to leasing the mats.
