

Community Development

- Associate Planner David Gress attended the Mid-America Regional Council Scenario Planning Workshop at the Kauffman Foundation.
- Department staff initiated a <u>rezoning</u> of the city block that contains T.B. Hanna Station Park, located between Olive, Maple, Adams and Washington streets. The rezoning from its current residential and commercial zoning designation to the Parks, Recreation and Public Use district designation will allow for future park improvements to be made. A Good Neighbor meeting will be held at 6 p.m. on Wednesday, Feb. 8, in the City Council Chambers.
- The Planning & Zoning Commission will meet at 7 p.m. on Tuesday, Feb. 7, to discuss the status of work on the Communities for All Ages master plan.
- Director Jim Cadoret, GIS Coordinator Heather Eisenbarth, Chief Jan Zimmerman, Capt. Roger Mayberry, and Communications Supervisor Starlith McAdams met with representatives of the U.S. Postal Service to discuss the overlap areas of Zip Code boundaries and the City Limit boundary.
- Derek and Pamela Mills filed a <u>request to vacate</u> a portion of an easement on the undeveloped lot they own at 1214 Kingsland Circle (Edgewater Lot #37) in Creekmoor. The reduction of the easement width from 25 feet to 20 feet will allow for the property owner to construct a home on the lot. City Council will consider the request at its Feb. 27 meeting.

- Recreation staff worked with Challenger Sports to schedule a competitive trainer for the Raymore United Soccer Club and promote their youth soccer camps offered at Recreation Park during the summer.
- Recreation Coordinator Jerri Keith contacted local vendors, sponsors and volunteers regarding Friday Food Fest, Easter Festival and Touch-A-Truck events.
- Recreation staff contacted local colleges and universities about posting seasonal and camp job openings.
- Staff held a pre-bid meeting and site walk-through on Monday and Tuesday for the loop trail and ADA-accessible baseball field projects at Memorial Park.
- Staff opened bids on Thursday for the Fourth of July fireworks display contract.
- Park staff received the new Disc Golf Course signage and sign posts, installation will be begin Feb. 6.
- The City Council and Parks & Recreation Board held a joint meeting on Monday, Jan. 30. The meeting gave both groups the opportunity to discuss the proposed designs for the Hawk Ridge Park improvements and the future management of the Raymore Cemetery.
