Rex Brauner, owner of Ramm Transmission, 202 W. Walnut, stated the business is behind on sales tax payments and he is working to bring his payments current. He asked Council for additional time.

Mayor Pro Tem Moorhead suggested the business owner might benefit from the help of a tax professional.

Councilmember Kellogg stated this business has been before the Council in the past and asked staff for history.

City Clerk Jeanie Woerner stated this business was on the August 8, 2016 agenda, continued at that meeting to August 22, then continued to September 26. The business provided compliance on September 22.

Councilmember Seimears asked Mr. Brauner how much time he was requesting.

Mr. Brauner asked for 4 weeks.

Councilmember Abdelgawad asked the business owner if they were on a payment plan with DOR and how long he has been in business.

Mr. Brauner, stated he was placed on a payment plan in August/September of 2016 and has fallen behind on the payment plan. He stated moving forward, the business sales tax would be placed in a separate account. He has owned the business for 5 years.

Councilmember Holman stated he wants the business to be successful and gave Mr. Brauner a warning on waiting until the last minute on his business matters. He is hesitant to provide more than one extension.

Councilmember Barber stated his support is based on the owner taking responsibility and that the owner has stated a solution.

Mayor Pro Tem Moorhead asked for an amount the business is behind on.

Mr. Brauner stated \$3,300.
