All plan holders are hereby notified and agree by signature below, that the bid includes consideration of the following changes, amendments, and/or clarifications and costs associated with these changes and are included in the bid.

Addendum No. 1 - Appendix A

Update Appendix A - Section 6 'SPECIAL CONDITIONS' as follows:

Add:

- Contractor shall create one set of concrete compressive strength cylinders each week concrete is placed on this project. Four cylinders per test site shall be required. Testing shall be a subsidiary of the sidewalk installation.

Replace Jefferson Creek Inlet with the following:

- *Jefferson Creek Inlet:* The unit price named in the bid shall be for the Lump Sum (LS) installation of a curb inlet box with lid over an existing storm sewer pipe (2-24" Corrugated Metal Pipe with 12" spacing between pipes) and the removal and replacement of curb associated with the installation of the inlet up to 40 Linear Foot. Bid item shall also include: backfilling the inlet with compacted AB-3 or flowable fill, cutting existing storm pipe and attaching to new inlet, site restoration and hauling off excess materials. **The contractor shall determine the correct height and openings of the proposed field inlet box and shall submit shop drawings prior to construction.** The unit price shall cover all labor, material and equipment to install the curb inlet over an existing storm sewer pipe. The location of the curb inlet is on the proposed sidewalk side of South Jefferson Street approximately (115') northwest of S Adams Street. The site shall be restored to equivalent or better condition.
