Sean Seibert, representing Ct Midland LLC, 64 T Street Lake Lotawana, Mo, provided information on the rezoning, aesthetics of the buildings, and the master plan associated with the development.

Community Development Director Jim Cadoret provided a review of the staff report included in the Council packet. Sean Siebert, representing Ct Midland LLC, is requesting to reclassify the zoning of Heritage Hills, Lots 158 thru 175, from "R-1" single family residential district to "R-2" single and two-family residential district. The 6.79 acre property is located on the south side of Pine Street, east of Madison Street which was platted in the late 1980's. He asked for the notices mailed to adjoining property owners, notice of publication, Unified Development Code (UDC), application, Growth Management Plan (GMP) and staff report be entered into the record. A good neighbor meeting was held May 3, 2017 and general questions were answered from citizens in attendance with no opposition heard. The Planning and Zoning Commission first heard this request at their meeting on May 16, 2017 and voted 7-1 to reject the request and recommend denial to Council. Following that meeting, the applicant chose to place their application on hold in

order to make revisions to address concerns heard from the Commission and to present an overall master plan of this area including surrounding properties to the north and east of the project area which are owned by this developer. The request was re-heard at the August 15, 2017 Planning and Zoning Commission meeting and at that time, the Commission voted 9-0 to amend their motion made at their May meeting, accept the staff proposed findings of fact, and forward the request to Council with a recommendation of approval.

Councilmember Berendzen asked the applicant about any planned green space or play areas.

Mr. Seibert stated the third phase does include a park and detention basin with a walking trail.

Councilmember Kellogg asked for green space to be included in the first phase.

Mr. Cadoret explained this request is only addressing the rezoning of existing platted lots that have previously been approved and laid out several decades ago. In the proposed master plan, the applicant is proposing open space with a detention area which is a requirement. He explained future procedures that would need to be followed with the Park Board, Planning and Zoning Commission and Council.

Mr. Seibert stated when Pine Street is developed, making connection to the phase one area, the detention basin will have to be constructed in the open space of the southeast corner. The trail around the basin will be installed at that time.

Mr. Moorhead reminded Council Bill 3292 is only the rezoning for phase 2.

Councilmember Townsend stated concerns that the only controlled traffic signal will be at North Madison and 58 Highway.

Mr. Cadoret stated a traffic study will be conducted in the future for the intersection at Pine and 58 Highway. He reviewed other ingress and egress areas to this development.

City Attorney Zerr also reminded Council this request is only pertaining to the rezoning of this parcel.

Councilmember Burke asked for future notices of rezoning be sent to adjoining property owners, be expanded beyond the current 185 feet.

Discussion ensued.
