The construction of these segments of sidewalk will be incorporated into the City's 2018 program, beginning in September 2018, with the costs levied against the properties in a special tax assessment.

City Manager Jim Feuerborn stated this agreement will spur future development of the area. Good-Otis, LLC is moving forward with housing development in conjunction with this agreement as part of an overall project.

David Otis, representing Good Otis LLC, is requesting approval of the replat of Prairie View of The Good Ranch, a 65-lot single family subdivision proposed for the southeast corner of Hubach Hill Road and North Cass Parkway. At their September 18, 2017, the Planning and Zoning Commission voted 7-0-1 to accept staff's findings of fact with a recommendation of approval based on three conditions. Those conditions are the developer must sign the Development Agreement prior to the first reading by Council, the applicant must submit a revised plat showing revisions A through E from the staff comments contained in the staff report, and the applicant/developer must obtain an agreement from Public Water Sewer District (PWSD) #10 allowing the right-of-way of Brook Parkway to be platted over the existing water main easement. If this first reading is approved by Council, the second reading will be placed on hold until all of the conditions have been met.

Councilmember Burke asked about the nomenclature in the title of the Bill referencing "final" plat when this is a replat.

Mr. Cadoret answered that as long as the nomenclature is correct on the plat, it is not an issue.

Councilmember Abdelgawad asked for a price range of the homes to be built.

Matt Schlicht, Engineering Solutions, 50 S.E. 30th Street, Lee's Summit, MO, stated this development would be similar to the Stonegate subdivision with houses being in the \$250,000-\$300,000 range. The developer has been interviewing builders to grow the subdivision quickly.

City Manager Jim Feuerborn noted to the Council that this subdivision had been brought to Council previously by a different builder with a proposal of smaller lots and and high density plan. This was denied by Council. In this request, the developer is bringing forth the proposal with larger lots.

Mr. Cadoret expanded on staff comment #13 in the staff report. The final plat shows the location of the where the water district's utility easement will be for the service lines within the subdivision. The main transmission line is under Brook Parkway and individual service mains will need to be constructed to serve the individual lots. The water district requires an exclusive 30' easement from their water main. This is separate from right-of-way and the City's 10' setback requirement along the property line. The combination of these setbacks forces the homes to be setback 40' from the front property line. A 30' easement would be standard in a rural area, with large acreage lots, but not in an urban setting. This has significant impact on the subdivision. This is why the requirement has been placed that the easement issue be settled between the water district and the owner/developer before second reading.

Mr. Feuerborn stated for the record, that this is a conflict when you have a rural water district providing service to an urban development. The 30' easement becomes an issue when a proposed urban subdivision doesn't contain the large, acreage lots.
