

Raymore Animal License Application

City Code requires all dogs and cats residing within the City Limits of Raymore to be licensed and registered with the City annually.

Licenses must be obtained by January 1. Animals not licensed by January 31, will be considered delinquent.

Animal licenses may be purchased at Raymore City Hall, 100 Municipal Circle, Raymore, Missouri 64083, between the hours of 8 a.m. and 5 p.m., Monday through Friday, or at the Raymore Animal Shelter, 1023 S Madison Street, by appointment. When applying for a license, bring a copy of a rabies vaccination record from your vet for each animal along with this filled out form. It is not necessary to bring your animal to the shelter.

If applying by mail, please provide the following: copy of rabies certificate, filled out license application, self-addressed stamped envelope so we can return your license. Mail application to Raymore City Hall, 100 Municipal Circle, Raymore, MO 64083

City Code Section 205.070 Registration Fee

Any person, firm, or corporation owning, keeping, or harboring any dog or cat over the age of six (6) months within the corporate limits of Raymore, shall pay an annual registration fee as follows:

\$5.00 for each spayed female or neutered male

\$20.00 for each unaltered male or female

AFTER JAN. 31, FEES ARE AS FOLLOWS: \$7.50 for each spayed female/neutered male

\$30.00 for each unaltered male or female

City Code Section 205.90 Anti-Rabies Vaccination Required

Any person making application for license for a dog or cat shall be required to present to City Hall at the time of making such application a certificate issued by a licensed veterinarian only, showing that such dog and/or cat has been vaccinated with a recognized anti-rabies vaccine and showing that the vaccination so administered to such dog or cat administered within the calendar year in which the application is made.

City Code Section 205.100 Number of Dogs and Cats

The owning, harboring or keeping of dogs and cats over six (6) months of age in excess

of four (4) (any combination) upon any property in the City of Raymore, shall be deemed a nuisance per se, provided, that the owner or keeper may secure from and at the discretion of the City Council, a permit to keep or harbor dogs and cats in excess of four (4) upon adequately showing that the premises are so situated and that special circumstances exist which would not constitute a nuisance to the neighborhood.

City Code Section 205.110 Running at Large Unlawful It is unlawful for any owner of dogs and cats to allow said

It is unlawful for any owner of dogs and cats to allow said animal to run at large within the City of Raymore, Missouri. An animal shall be deemed running at large when found upon public or private property when not under the control of the owner.
