State law requires each political subdivision in the State of Missouri, except counties, to fix their ad valorem property tax rates not later than Sept. 1 for entry in the tax books. Should any political subdivision whose taxes are collected by the county collector of revenue fail to fix its ad valorem property tax rate by Sept. 1, then no tax rate other than the rate, if any, necessary to pay the interest and principal on any outstanding bonds shall be certified for that year. She explained the staff memo provides specific information on how the proposed levies for the coming year were derived. The proposed 2018 levy, based upon the principle of revenue neutrality mandated by the Hancock Amendment, is \$1.2856 per \$100 of assessed valuation which is the same as 2017.

Councilmember Holman noted this does not raise taxes nor has the City raised taxes in the last 13 years.
