### **Public Art Committee Meeting for Tuesday, November 6.**

We began with a proposal from the Parks & Recreation Department. We had originally set aside \$7,000 of our budget to purchase and donate a musical instrument structure for the Hawk's Nest Playground in the new Hawk Ridge park. Hawk's Nest playground is a universally accessible, or "inclusive playground," easily accessible to children with all abilities. This will be Cass county's first inclusive playground.

Or maybe the second? Flush with an unexpected influx of funds, the P&R department now plans to create an inclusive playground in TB Hanna Park as well, though this construction will begin before the construction begins on the Hawk's Nest playground. With this new opportunity for the city, the P&R department has proposed that our musical instrument structure be placed at TB Hanna instead of Hawk's Nest.

The members were reluctant to make any immediate decision on a matter that includes such a big price tag (and large portion of the Commission's overall budget).

Some of the concerns were as follows:

- 1. Are we giving the impression that our decisions for the city are based on whimsy rather than careful planning and gathering of information? Or will this early placement generate excitement and encourage other groups & businesses to donate for playground equipment at Hawk's Nest?
- 2. Will that type of playground equipment fit with the overall theming of TB Hanna or should we look at a different piece? Is theming something we should concern ourselves about?
- 3. Will a musical instrument structure be too disruptive or loud for the park neighbors or the artists who perform at the farmer's market during the Summer? Or is it a good fit, since we already have a number of music events there already?

We wanted to bring this up in our Art Commission meeting to get other Commissioners' thoughts on this proposal before we make a decision at our next committee meeting.

(This took most of the time. The rest of the meeting went much faster.)

Mike asked if we'd like to be part of the Holiday Tree Trail at TB Hanna park for the Mayor's Tree lighting ceremony and we would. We plan to purchase or replace some lights and use our existing ornaments and I will contact Mike with a date and time for the tree set-up.We'll get that info to everyone and ask for volunteers to help set up. (Deadline for setup is 4 pm November 30th.)

Mike reported that a contract has been signed with JT Daniels to create the four murals at the structure by the soccer fields at Recreation Park. Because this project has expanded to include an additional three walls, Mike is making a presentation to the P&R department November 27 at 6 pm to communicate this opportunity and get their blessing to move forward (and forgive any overreach). If you'd like to join Mike for the presentation, the meeting will be at the Municipal building.

Mike also brought an idea to to place on our radar. A vanity publishing opportunity to create a hardback coffee table book about the city of Raymore, in hand and for sale to everyone just in time for our 150th anniversary of the city's incorporation. Though a few years away, content development for projects like this can take 1-1.5 years. If we decide to do something of this magnitude, we will need to work closely with other groups, including the Historical Society, as well as develop a plan to decide what kind of book we want to see published. A project like this might take generating a new committee.

Harriet ended the meeting with a charge to begin thinking of a way to soften the look of our main travel artery, 58 highway. Do some research and see what others do to give an otherwise commercial thoroughfare some character. The example given was the 2D structures along Interstate 435 North and Southbound lanes just north of Bannister Road.

4th of July art activity at Summer Scene


We may possibly help teach a class during the Spring Vacation Camp offered by Parks, but again that will be determined at a later date.

If any of the other commissioners know of people willing to teach or lead classes, or have other ideas, the members would appreciate input.



## Q1 To what degree do you or your family members feel it is important for the City of Raymore to incorporate more arts into the community?





## Q2 What are the best ways for you to stay informed about arts events, arts news items, and/or Arts Commission activities?





## Q3 What are the areas of the arts most interesting to you or your family members?





## Q5 Why do you participate (creating and consuming) in the arts?





## Q7 What types of arts activities do you or your family members participate in in Raymore?



## Q8 What types of arts activities do you or your family members participate in outside of Raymore?





## Q9 To what degree is arts education in Raymore a community priority?





## Q11 What are the top arts priorities for the City of Raymore?


