Here are my notes for this morning's meeting:

- 1. We discussed the yet-to-be-scheduled upcoming meeting with Mural Artist, JT Daniels. Members of the Parks & Recreation Board will be invited to this meeting which will go over the concept(s) for the four-paneled mural at the Recreation Park Concession building.
- 2. All Art commissioners are invited as well, but Harriet suggested a special invitation to Commissioner Laura Richardson because Daniels has discussed a local student outreach/participation program on a portion of this project and we'd like someone with her years of teaching experience review that part of the proposal.
- 3. The December 11th Christmas Sing-a-long at St. Paul's Methodist Church was a BIG success and we'd like to send official "Thank You" correspondence to all who helped make this event happen. Stay after the Commission meeting to sign a few letters/cards. (Also, a HUGE "Thank You" to Pat, for coming up with the idea and leading this effort to its fruition.)
- 4. We discussed generating concepts and designs for the (is it 12?) large banners that will be attached to light poles along 58 highway. (Specifically, what the message will be, assuming this will be a "Raymore" centric banner and not a seasonal or event banner.)
- 5. We discussed redoubling our efforts to get local artists to exhibit in our available space. (Current construction can be a hindrance, but that will be done by March.)
- 6. Pat suggested generating an interim exhibit, showcasing all of the events the Arts Commission has held and sponsored. (Photos of all of our events will be a great reminder of how many different special events and occasions we've had so far. and can be inexpensively mounted and hung around the available space while we find artists who want to exhibit.)
- 7. We thanked the Commission Staff for taking down the Arts Commission Christmas Tree! (We also thank them for coordinating the initial setup on November 30th.) Speaking of which, we would like to purchase more Adirondack Chair Ornaments for the tree next year. (Maybe we can have a station at Summer Scene where people can "Help Us Paint Our Christmas Tree Ornaments!")
- 8. We briefly discussed possible location issues with this year's upcoming Summer Scene.
- 9. Finally, Harriet has asked us to identify specific locations along Raymore's borders that we can mark as possible spots for future art placements.

### **AGENDA ITEM MEMO**

**Re:** Budget Amendment

At its Aug. 2018 meeting, the Commission voted to approve the FY 2019 budget directing funding and resources for the fiscal year. As part of the that budget the Commission approved \$7,000 for musical elements at Hawk Ridge Park. The purpose was to be part of the inclusive playground at Hawk Ridge, which was looking for community donations to help fund specific elements on the project.

Shortly after budget approval, the Parks & Recreation Department received a \$135,000 donation from Variety KC to accelerate a similar - though smaller - Park Improvement Project at T.B. Hanna. This donation will allow the Parks & Recreation Department to turn T.B. Hanna in to an inclusive playground and sprayground - the first of its kind of Kansas or Missouri.

Construction is estimated to begin at T.B. Hanna this winter and the park is slated to open this summer. Construction at Hawk Ridge is not expected to begin until late 2019 or early 2020.

This budget amendment would reallocate money approved for musical elements at Hawk Ridge to musical elements at T.B. Hanna Station.
